Major Deliverer: Where an event organiser hosts 10+ events in a year, at a Gold Standard, they will be eligible for Major Deliverer pricing. This will be determined on a case by case basis with AusCycling. In determining this cost AusCycling will review:

- Past performance of the organiser (safety, insurance claims, Commissaire Reports)
- Total Number of Events
- Total Number of Participants

Achieving Gold Standard Delivery:

To be recognised as a Gold Standard Organiser the following must be achieved for at least 3 consecutive years prior to any application:

- Positive President of the Commissaire Panel Report
- Event sanction with AusCycling (or predecessor organisations)
- No major incident reports or insurance claims resulting from any event conducted by the organiser
