| Major Deliverer: Where an event organiser hosts 10+ events in a year, at a Gold Standard, they will be eligible for Major Deliverer pricing. This will be determined on a case by case basis with AusCycling. In determining this cost AusCycling will review: | | |

| Achieving Gold Standard Delivery: To be recognised as a Gold Standard Organiser the following must be achieved for at least 3 consecutive years prior to any application: <ul style="list-style-type: none"> • Positive President of the Commissaire Panel Report • Event sanction with AusCycling (or predecessor organisations) • No major incident reports or insurance claims resulting from any event conducted by the organiser | | |
