Sport and physical activity has enormous influence on our nation's health, education, social, economic and diplomatic outcomes.

It's why Sport Australia and the AIS remain steadfast in our vision: to make Australia the world's most active sporting nation, known for its integrity, sporting success and world-leading sports industry.

Australia's commitment, outlined in the Australian Government's national sport plan, Sport 2030, is to reduce physical inactivity by 15 per cent. It's a huge challenge Sport Australia enthusiastically accepts. We are making significant progress and Sport Australia's programs are benefitting sport, as well as broader community health and wellbeing, including tackling issues such as obesity. Our partnerships with National Sporting Organisations (NSOs) remain fundamental, but we are also engaging more than ever with other networks to grow our sporting industry. Collaboration with physical activity providers, health, education and various levels of Government can deliver more for sport and all Australians.

This was highlighted in 2018-19 when Sport Australia, on behalf of the Australian Government, delivered \$150 million in new participation programs. The \$100 million Community Sport Infrastructure grants program is enhancing hundreds of grassroots facilities across Australia. The \$28.9 million Participation grants program is encouraging innovative programs that help break the down barriers to physical activity. The new \$22.9 million Better Ageing grants program is helping senior Australians 65 and older to get more active and socially connected.

Our national Sporting Schools program remains a key platform to address childhood inactivity and drive generational change. We have funded 7300 schools and recorded more than 5.2million attendances since its launch in mid-2015. We continue to look at ways to maximise the impact of Sporting Schools and link it with our work in physical literacy. By teaching our children to run, throw, jump or kick, we put them on the path to better lives.

There is no success without integrity. We continue to encourage environments that are inclusive and welcoming. Increasing diversity in our industry is critical and we want to make sport the benchmark for a more equitable society.

All this work is emphasised by our national behaviour change campaign, Move It AUS. Our call to action is to 'Find Your 30' minutes of physical activity every day, and enjoy the benefits.

We are continuing to build the capability of the sports industry, addressing governance reform to bring out the very best in our sporting organisations. The One Management project looks at helping sports align their strategy, workforce and financial management.

The AIS, in partnership with the National Institute Network and National Sporting Organisations, is aligning Australia's high performance sport strategy too. The National High Performance Sport Strategy 2024 signals the first time all Federal and State/Territory sports agencies have signed up to a joint high performance strategy.

In November 2018, the AIS announced an updated investment model for high performance sport and through this improved framework, Olympic, Paralympic and Commonwealth Games sports will benefit from a longer term approach to funding. Instead of annual grants to sport, for the first time the AIS is providing longer-term funding commitments to give sports more stability and certainty to plan ahead.

All of this work is important with the 2020 Tokyo Olympics and Paralympics drawing near, and the 2022 Beijing Winter Games and Paris 2024 beyond that.

Enhancing athlete pathways and athlete wellbeing are primary areas of focus for the AIS, and are keys to creating long-term sustainable success. We have embedded 20 Athlete Wellbeing Managers across National Sporting Organisations, and, working closely with the AIS Wellbeing and Engagement team, are delivering key programs and support from mental health programs, through to career guidance and connection to Australians at the community level.

The AIS is also leading collaborative sports research, applied technology and innovation initiatives including the Gold Medal Ready program, a unique partnership with the Australian Army to help athletes perform under pressure. From backyards to benchmark international events, we believe unquestionably in the power of sport and physical activity to reflect the very best in our culture and to be a powerful vehicle for change.

Thank you for all you do for Australian sport and best wishes for the year ahead.

**WELL 1 YEAR IN AND WHAT
AN EXCITING AND FAST
PACED EXPERIENCE!**

The past year has once again been a busy time for BMXA Australia, with progress made on many fronts while also committing significant time and energy to examining the best long-term structure for BMX to ensure it remains well placed to grow in an increasingly complex sporting landscape. As with any year, the positive outcomes for the sport are a result of the hard work of many people from every level of the sport and we are thankful for their efforts to keep BMX on the right track and moving forward.

The biggest issue for BMX, and the other cycling disciplines, this year was the AusCycling project. This was a combined effort of the three cycling nationals sporting organisations, BMX Australia, Mountain Bike Australia and Cycling Australia, to examine the best governance structure for cycling in the country, so that it would not just keep its head above water but actually flourish. The project was supported by Sport Australia. The model that is being put forward aims to reduce the number of cycling organisations in the country from 19 to 1 national organisation with offices and staff in each state. The proposal represents a significant shift in the way all cycling disciplines are managed in Australia and I acknowledge that some members will feel some nerves with the proposal. However, I would like to stress that the BMX representatives on the Steering Committee have worked hard to ensure that BMX will be treated with respect in any merger and BMX will be an important part of the merged entity. Of course, any such change will only happen with the support of a majority of our members and at the time of writing the voting process at state level will shortly commence. The view of the member clubs will be respected, whether in the affirmative or negative and the board of BMXA will act accordingly.

Once again, this year the office staff have worked hard to service our members in the best possible way and have been looking to continue the work of recent years in automating as many of our systems as possible. This move away from paper-based systems presents not only time savings in the administration of the sport but also makes it easier for our members to keep their membership and accreditations up to date.

The move to virtual membership cards on mobile phones for all members and the enhancements on the BMXA app have been well received and we are currently working on bringing our coaching course theory module online in 2020, which will be another great step forward, allowing prospective coaches to do the theory component of the coaching courses in their own time.

This year we have been fortunate to access some extra funding through Sport Australia to help with the development of several areas of our sport. As a result of the Sport Australia Move It AUS Participation Grant clubs will have the opportunity to seek grants to help conduct introductory programs for females, while a number of coach development opportunities will be made available to coaches in 2020. We trust that these will supplement the amazing work being done at club level to help grow the sport.

We were pleased to be able to successfully run our National Series and National Championships events again this year. The National Championships was held in Shepparton in May, thanks in part to some wonderful support from the Victorian State Government and the Greater Shepparton City Council. This year's event included our usual classes but also saw the introduction of the Pro Spectacular, which brought together our Sprocket Rockets and Pro riders in a way that gave our young riders the chance to get up close and personal with their heroes while showing the great support the Pro's have for the next generation of BMX'ers. In the Elite classes, Izaak Kennedy took out his first Elite National Championship, while Leanna Curtis added another National Championship to her impressive resume.

The National Series had an event conducted in each state/territory (except for Victoria, the host state of the National Championships). While the racing was great, our entry numbers were down in comparison to the previous year, indicating that the current structure may not be resonating with our membership base. We will need to review our national events structure, and if necessary, make some changes, to ensure it is meeting the needs of both the members and the organisation.

Regardless of entry numbers, the team of staff and volunteers that put on the events did an amazing job again this year, ensuring each event was professionally conducted and gave the riders an enjoyable event. National Events Manager, Emily MacIver and National Officiating Director, Paul Connors worked smoothly with the host clubs and the team of volunteer officials to conduct a series of great events. Well done to all.

While on the subject of events, we are looking forward to early 2020 when Australia will host two World Cup events. With crucial UCI ranking points on offer and countries working hard to qualify for the Tokyo Olympics we are confident that the events will attract the best riders in the world to Australia. It has been many years since Australia hosted an event of this calibre and we are thankful for the Greater Shepparton City Council and the Bathurst Regional Council for their commitment to hosting these events. It will provide our members with a great opportunity to see the world's best riders in our own back yard and I am sure it will be well attended.

Our communications team has once again provided the members and general public with an amazing service throughout the year. They work hard to keep everyone up to date with what is happening in the sport, providing weekly wrap ups of racing around the country, human interest stories from clubs throughout Australia and the normal news from BMX Australia. They are the first to provide news of our country's riders at international events, often staying up to the wee hours of the morning to ensure you had the World Cup news as you woke up in the morning. I thank them for their efforts and hope you have enjoyed reading their news.

There are many people to thank for keeping the sport moving forward this year. To the many club volunteers that help to run local clubs and get our members on the track, I would like to record our thanks for the work you do. It is a special person that takes on the responsibility of ensuring that other people enjoy their participation in the sport and without the efforts of thousands of volunteers across the sport BMX would not have had as successful a year as it has. Thank you for your efforts.

I would also like to thank the Boards and staff of the State and Territory Associations. It has been a year full of robust discussions, especially around the AusCycling proposal. While not everyone agreed on every aspect those discussions were always respectful and came from a desire to ensure the best outcomes for our members. Thank you for your work at state level and your contribution to the sport.

I should also record my thanks to the Board and staff of BMX Australia. The staff work extremely hard and are always looking for ways to improve our service to the members. Thank you for your dedication to BMX and the contribution you have made over the past year. To Darren Alomes and the Board members, thank you for taking on the difficult task of providing oversight and guidance for the direction of the sport. Regardless of the outcome of the AusCycling proposal, BMX has some interesting times ahead. I look forward to seeing where the sport is at in another 12 months.

2019 has been a very busy and exciting year for BMX from a National Perspective. For the second year we had a National Series that has had events that have covered all four corners of this great country. Not only have we been to every state and territory with the National Series, the events were very much inclusive events offering classes across all categories of riders.

The 2019 National Championships saw the BMX community heading back to Shepparton BMX Club. Again, there were a healthy number of volunteer officials who assisted with running the 2019 BMX National Championships in Shepparton and without these people the event would not have been the success that it was. On behalf of the Board of BMX Australia I would like to thank each and every one of our members of the volunteer army. A great job WELL DONE and a huge THANK YOU.

The 2020 National Series planning process has already commenced, given the costs associated with running a National Series event a revised format that will include only 5 stages throughout 2020. There has also been a significant review on cost structure along with the racing format being reduced to 1-day events. Given the number of Superx events planned for 2020 and in addition to the Continental Championships which will be held during the week of the National Championships, the 2020 National Series will not include any UCI events.

At the date of this report the National Technical Committee are in the process of reviewing the 2020 BMXA Rule Book. There have been a number of suggestions for rule changes from the respective State Boards. In addition to these suggestions, the BMXA National Technical Committee held a meeting with a number of mature age riders during the 2019 National Championships in Shepparton. During this meeting a number of suggestions were discussed including age bracket for classes offered for riders over the age of 30 and the number of designated masters classes. The meeting was very productive and a number of the suggestions will be included in the 2020 BMXA Rule Book.

We have enjoyed a great year in terms of the number of volunteers continuing to put up their hands to assist. As we know a "volunteer is the most valuable resource within our sport and without these people our sport would not survive"

In this FY year there has been number of State Level Commissaries Courses and a National Commissaries Course which was held during the 2019 National Championships.

I would like to acknowledge and thank BMX Australia staff members, Martin Shaw, Toni Hume, Sylvia Armstrong, Daniel Spence and Emily MacIver. Without the support of this talented team of people we would not be able to deliver the support and service levels to the BMXA community.

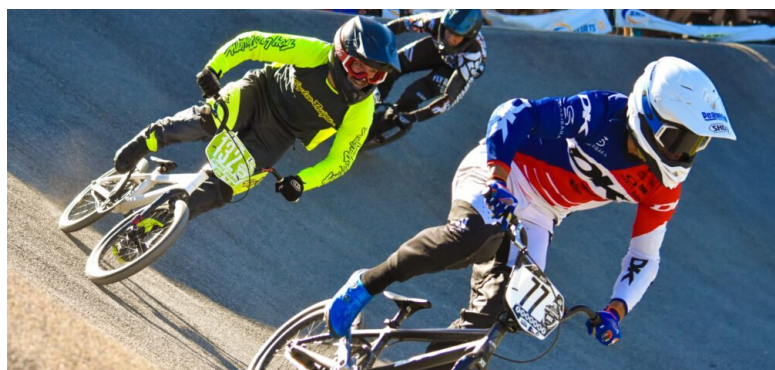
2019 has been a busy year for Finance. Our events have been well run with healthy attendance.

Feedback from our members has been positive and interesting. We will focus on ensuring these events are self-funded and tightening the budgeting around them. The events company, which had been a separate entity has been rolled into BMX Australia which will help to simplify the accounting and reporting for the organisation going forward. There will be some further work to ensure we are keeping a keen eye on the financial results for our events going into 2020.

Our result for the 2019 year was a profit of \$85,681 in comparison to 2018 Loss \$65,468 and there has been continued emphasis on expenses and finding savings for both the administration of BMX and the running of events. BMX was also fortunate to be awarded a grant which is able to be used to expand programs for participation, coaching and pathways. Expenses which have increased over the year are insurance, staff costs and our digital and TV expenses used at our events and for marketing and promotion. Our balance sheet looks stronger compared to 2018 and this again allows us to support the initiatives in play for the organisation in the upcoming year.

There is much change afoot with time taken at Board level and for our CEO around the AusCycling proposal. We will endeavour to improve processes, service and outcomes for our membership and look forward to 2020 with anticipation. I want to thank the staff and CEO for their fantastic efforts this year and also the Board for their support and counsel. I look forward to working with you all over the 2019/20 year.

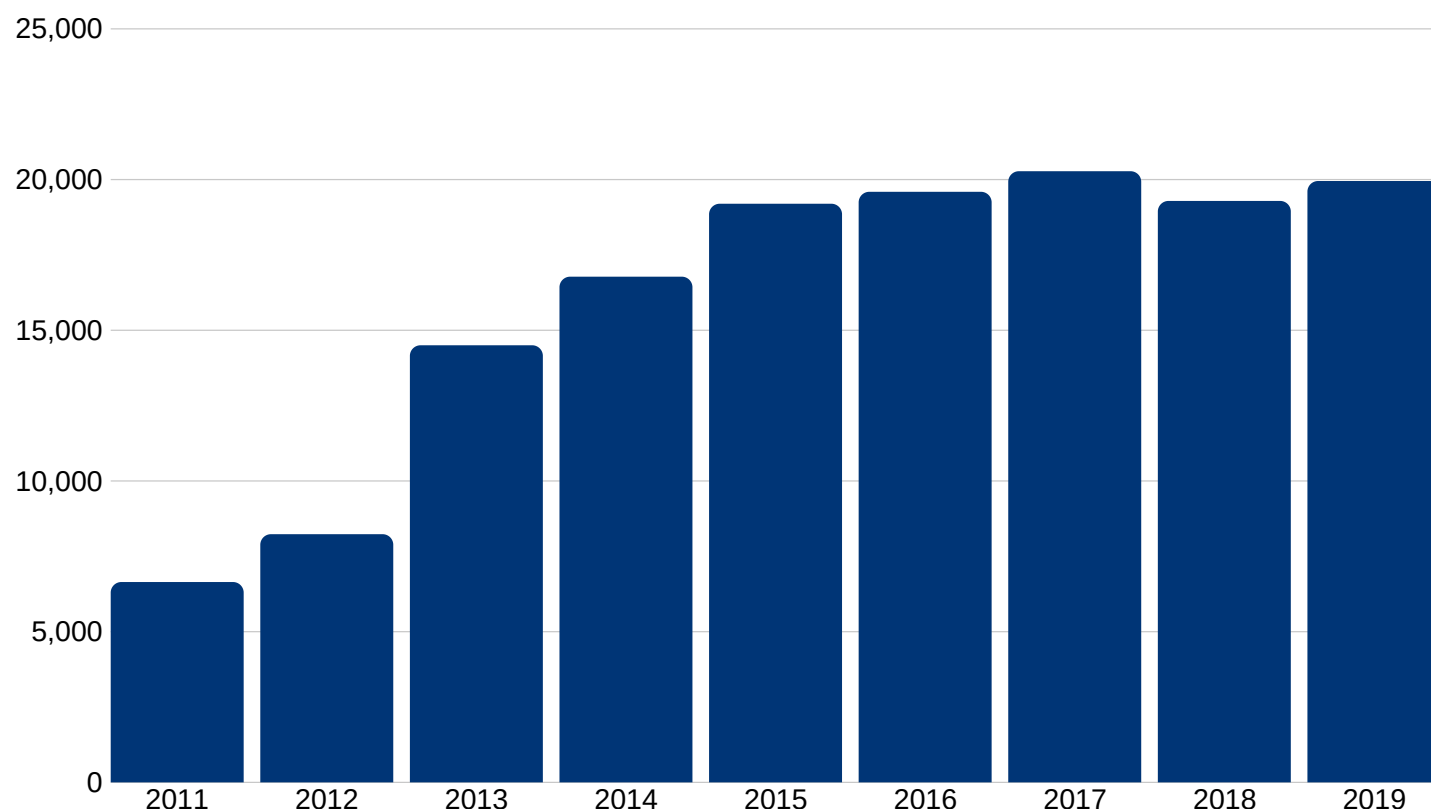

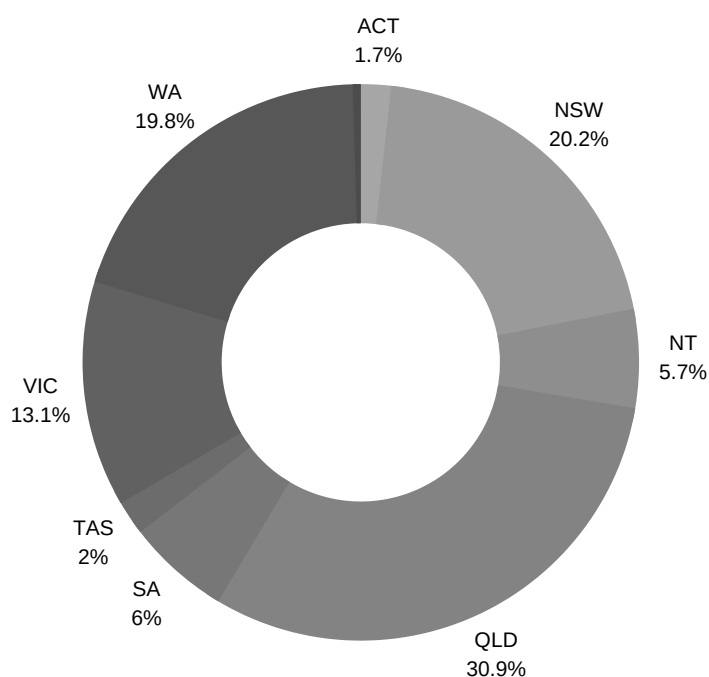

NATIONAL EVENTS REPORT

EMILY MACIVER

NATIONAL SERIES

The BMX Australia National Series had a new look and feel in 2018, with seven rounds of competition conducted over two days. The latter half the year wrapped up with rounds at Nerang BMX Club (QLD) in July, Cross Keys BMX Club (SA) in August, Tuggeranong BMX Club (ACT) in September, before the final round at Launceston BMX Club (TAS) in October. Clothing apparel brand Bad Boy jumped on board in late 2018 as the naming sponsor of the National Series and National Championships with the series becoming known as the 2019 BMXA Bad Boy National Series.

Following a review of the National Series at the end of 2018, feedback from riders was that there was not enough racing over the course of a weekend to make it attractive. As such it was decided to increase challenge racing to four motos plus finals to provide riders the opportunity for more racing over a weekend. UCI events also incorporated a superclass round on the Saturday to give pro riders the opportunity to compete both days. NT, SA and TAS stages were also been reduced to one day to account for the smaller numbers competing in these locations. The series also reduced the minimum number of rounds for rider eligibility to 1 round.

Unfortunately, the change has not seen number increase with NSW and NT stages both seeing a decline in numbers. Despite improved messaging and targeted videos for local riders, local attendance continues to be low and the series structure is failing to attract the required numbers to make it sustainable. The misconception that it is a 'national event' and is only for 'good' riders, along with the perception you need to compete in every round also seems to deter riders from competing. BMX Australia will be undertaking a full review of the National Series for 2020 with a revised event structure likely.



Aside from the lack of numbers, the National Series events ran incredibly smoothly thanks to the outstanding team of BMXA staff and officials who were on hand to assist. After a full cycle of events in 2018, the team knew their roles from beginning to end and confidently delivered quality events with minimal incident. Their commitment and professionalism is a credit to them and their support is invaluable in the conduct of national events. A big thanks to Daniel Spence who stepped up on a number of occasions during the year to run national series events. He did a great job and should be congratulated for his efforts.

2019 BMXA BAD BOY NATIONAL CHAMPIONSHIPS

Riders from every state and territory descended upon Shepparton BMX Club from May 20 - 25 for the 2019 BMXA Bad Boy National Championships. The event this year also incorporated the inaugural BMXA Pro Spectacular on the Wednesday to kick start the racing action..

There were 1446 entries (1164 riders) for the National Championships with strong support from across the country, in particular NSW, QLD and VIC. There were 57 classes from Sprockets through to 50 plus years and Masters, along with Men's and Women's Elite and Junior Elite classes.

The 2019 BMXA Bad Bay National Championships incorporated the inaugural Pro Spectacular on the Wednesday which was open to Superclass and Masters Riders with the chance to win some great prize money. 54 Superclass riders and 13 Masters riders competed in the event which also incorporated the Sprocket (under 8 years) buddy system, where Sprockets were paired up with a pro rider for the afternoon. The Sprockets had the opportunity to meet their rider prior to racing with the 16 Superclass finalists (8 men and 8 women) sharing a lap around the Shepparton track with their newest fan after the event's final. The initiative aimed to inspire the next generation of riders by providing them the opportunity to interact with the best riders on the track. The feedback received from the Superclass and Sprocket parents alike was extremely positive and the initiative was hailed a great success.

With an array of accommodation options for varying budgets, supermarkets, restaurants and amenities close to the track, along with tourism opportunities for visiting families, Shepparton was a great location for the National Championships. The facility itself was well equipped for an event of this nature and had sufficient space for spectator viewing, pro shops, food vendors and event village.



Adjoining facilities were also utilised including the velodrome for staging and pit tents, the scout hall for officials and the soccer pavilions for registration. The close proximity of these facilities was beneficial for event operations. With Shepparton's addition of the 8m hill, the track also provided our Elite riders the opportunity to compete on a World Cup standard track, which helps give them the experience when competing on the world stage.

The livestreaming of the National Championships generated a total viewership of 125,464 with an average session duration of 00:05:17. Saturday was the peak day with 29,915 views closely followed by Friday with 29,816.

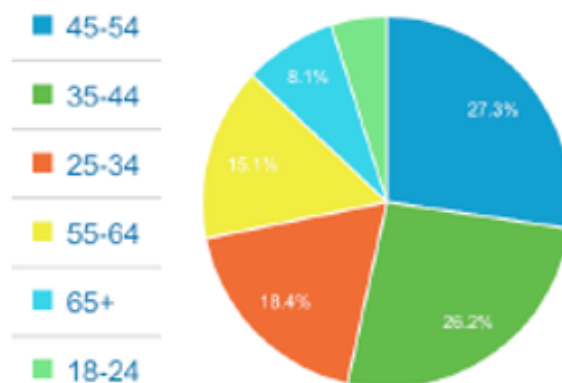
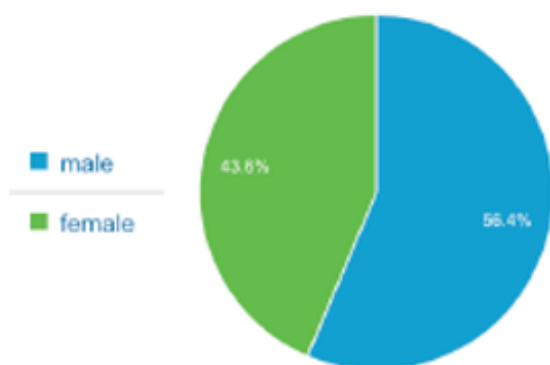

During the last 12-months Sports Communication Australia (SCA) has completed its fifth year as BMX Australia's (BMXA) Media and PR consultant.

In order for SCA to deliver a premium service, at least one member of the SCA team is in the office with BMXA staff weekly and is available seven days a week.

The main roles of SCA, on behalf of BMXA, during 2019, were:

- to report on BMXA organised events and other events contested by our members
- promote the sport via traditional and social media channels
- produce the weekly eDM The Dirt
- produce the monthly club based eDM The Clubhouse and launch The Official and the Inside Coach
- produce comprehensive digital coverage from the BMXA National Championships, including every final
- produce comprehensive digital coverage from every round of the BMXA National Series, including every final
- promote both internally and externally the Ride In2BMX program, including digital advertising
- management for BMXA's website and owned digital channels (Facebook, Instagram, Twitter and YouTube)
- content production for BMXA's website and owned digital channels
- liaison with key stakeholders around sponsorship and events

Over the last 12 months SCA has been able to provide all of these key roles as well as directing BMXA and its stakeholders on crisis management, media strategy and content marketing strategy.

Along with the BMXA Participation Manager, SCA continued to implement the Ride In2BMX program on BMXA's owned channels including paid and targeted Facebook and Instagram advertising

We continued to grow our engagement with 'grass roots' media outlets in local and regional continued, especially during state, national and international competitions. This has been combined with sustained state and national media coverage in main stream news, print, radio and online television.

Throughout 2019 SCA continued to provide written and video content from the BMXA National Series. The highlights included:

- An average of 37 videos produced per round
- An average of 124,000 video views on Facebook per round, as well as a considerable number of views on Instagram, Twitter and YouTube.

Other highlights included:

- An average of website 22 articles published per month
- An average reach on our social media content of 259,044 per month

As well as providing the National Series digital content, SCA will continue to report on all BMXA events and competitions as well as the national teams.

I feel ACT BMX is a little different than the other governing bodies as we only have two clubs to oversee, in which I'm hoping this will enable closer contact with each club in their development and ensuring their compliance with the BMXA rules.

Our board structure has remained the same as last year which has helped to build on relationships moving forward, as you would be aware we are in full support of the Auscycling concept and look forward to seeing this model progress.

Our major event for the year was our Championships, this year it was held at the track in Kambah hosted by the Tuggeranong BMX Club. We ended up with over 550 entrants which has been the highest number for quite a while.

In order to make the event the success that it was one of the main focuses early on in the planning phase was to engage sponsorship to allow us to focus on the actual running of the event and not getting hung up on the financial side of things, this was achieved and the event was run successfully whilst making a profit.

These events can't be run without the tireless help of volunteers and we are no exception to this, we were fortunate enough to have a committed team in place across both clubs and ACT BMX.

The focus for next year's Championships will not change a lot with the exception of it being combined with the National Series over the Anzac weekend, we feel this will be a great success and boost numbers in both events.

We provided financial assistance to 7 of our riders who headed to the World Championships this year representing Australia, this was something we had been talking about as a board for a while in what ways we could give back to the member and felt this was a perfect opportunity to do that, we will be looking at doing the same next year as it was very well received by all.

The main emphasis for myself as the lead of ACT BMX is ensure that both clubs are running in accordance with BMXA's rules, with the main attention being placed on ensuring that both clubs have sufficient accredited volunteers in place to run their events.

The other focus will continue to be the coaching and development of our riders, both clubs are very active in this and I feel it is extremely important for this to grow and develop with the increasing membership base of both clubs.

Coaching has been going extremely well at both clubs with three sessions being held weekly, this a very strong focus of not only ACT BMX but both clubs.

If it wasn't for the tireless efforts of the volunteering coaches giving up their time we wouldn't be able to achieve what we are only a weekly basis, generally all sessions are booked out with a waiting list.

This drives the need of getting more coaches in across the board which we have been pushing, we recently run a coaching clinic at the Canberra club which was well attended.

ACT BMX will continue to assist both clubs in whatever way we can to ensure what I have mentioned above comes to fruition.

We have also been very active on increasing our social media profile to get the ACT BMX brand out there, in the short time since being involved this has grown immensely, just the simple act of sharing other bodies communication has had a big effect, with the current forms of communication that we are portraying I feel we have a much better engagement with our members and other similar organisations, we have received nothing but positive comments regarding this. Continuing on the ACT BMX branding, we have made shirts for all of our members attending this year's NSW State Titles, we are hoping that this really makes us stand out as a unified outfit along with bringing both clubs together.

The Canberra BMX Club are only a few weeks away from hosting the National Series with all preparations going to plan in what should be a great event.

In summary ACT BMX will continue to work on improving our brand and focusing on the coaching and development of all our riders with a special emphasis being placed on the 8 - 14 age bracket.

THE BOARD OF BMX NSW

Executive Director

Mel Chambers: Strong governance/administration focus, highly organised and effective way of working. Open, approachable and determined to help clubs work through challenges they may have.

Events Director

Sarah Davis: Raised the bar on the quality and production of events and ceremonies throughout the year. She puts a huge amount of time into the presentation and delivery of awards, trophies, dinners, programs. A massive success has been the introduction of quality and affordable merchandise for the State Titles.

Rep Team Director

Peter Jaehne: The success of the Junior Test Team program rests entirely on the vision, drive and organisational skills of Peter. His attention to detail, implementation/delivery of processes coupled with the strong relationship built with BMX New Zealand has made an amazing product creating awesome experiences for riders and parents alike.

Marketing Director

Alex Bains: Secretary of the Liverpool club for many years, has great experience in the creation and submission of grant applications for clubs. Highly knowledgeable in governance and brings a pragmatic approach to dispute resolution.

Racing Director

Bluey Seaton: Driving force behind our successful events. Impeccable timekeeping and race directing skill, he is the reason why BMX NSW races always start at 10:00 on the dot. Phenomenal amount of work behind the scenes to ensure all race events run smoothly and efficiently.

Finance Director

Michael Craig: Effective management and processes around the BMXNSW finances. Over the past couple of years has improved the revenue distribution to clubs from race fees and increased the funding for the State Team.

Officiating Director

Ian Pitstock: Newest member of the board, has filled a huge void we had in this space. Working very closely with BMX Australia to standardise Officiating and line up with the National guidelines. Facilitation of level 2 officiating courses with good engagement. Built a solid team of officials

OFFICIATING

NSW board re-adopted the policy of only team and club representative's being able to approach officials at a race meeting as well as a zero tolerance to abuse from riders or parents. The response from that decision was immediate and very positive there has been a noticeable calm at the rest of the events after that and no officials were confronted by abuse.

BMXNSW has also started monitoring how many officials from individual clubs we get and are in the process of informing clubs that they are required to encourage the recruitment of officials to represent their club. This has been a great success - we had a good number of state level course attendances, 17 in total. We are currently in a good position for officials for States Titles and 2020 racing.

COMPLIANCE AND GOVERNANCE

There has been a strong focus in 2019 on our new riders. We are constructing a simple, effective yet concise document that provides a stepping-stone into BMX racing without confusing new members. One of the key tools underpinning the way we work has been the collaboration tool Confluence. All of our meeting notes, decisions, governance, key documentation, how-to's etc are all stored on Confluence and easily accessible. The use of the tool has been extended to clubs and we are now building up a fantastic repository of information, knowledge and history about BMX in NSW. Club Compliance has also been a big topic this year, having clubs responsible for uploading their own documents and information that is required by the state and also by BMX Australia. Much has been achieved and there is so much more to do.

EVENTS

2019 has been another busy year for the BMXNSW Events portfolio. The focus this year has been to fine-tune the big changes implemented in 2018 and look for efficiencies across the program, particularly with the suppliers that provide our event trophies, merchandise and jerseys. The success of last year's end of year awards dinner has been reflected in the 2019 numbers with an additional 80 tickets sold to take the dinner numbers just shy of 400. This is a result of the changes to the BMXNSW rider recognition program in 2018, following feedback from our membership base that they enjoy the pride that comes from being recognised for their efforts (more rewards = more participation). The BMXNSW States merchandise has been a success again this year, following the decision by BMXNSW to engage a merchandise designer and release range via an online store in the lead up to States.

MARKETING

2019 has seen another year focused on supporting clubs with their grant applications. Support letters were provided for six NSW Clubs to support recent grant opportunities. Our Marketing page has been updated with information designed to assist clubs to obtain sponsorship's, write successful grant applications, marketing strategies and other information about club governance.

BMX NSW will again provide this service in 2020 to assist clubs in generating secondary forms of income to fund projects for clubs and to promote your club within your local community. We will continue to liaise with state sporting organisations to ensure that we maintain high standards of governance and that our policies are up to date with Australian sporting sector requirements.

RACING

Significant changes were made to the calendar for 2019, the number of State events was reduced from sixteen to nine and only a State series was run, there were no Opens this year. The base structure where clubs were guaranteed a State event every year has been replaced with a structure where clubs need to show they are ready for a State event. This readiness includes, amongst other things, capability to run an event from a physical and financial perspective and also adherence to correct governance.

The revised calendar has been a success with over 500 riders at every State series and in two cases there were more than 600 riders. The reduced number of events over the year opened up the calendar for clubs so they could work on the grass roots of the sport. The number of Interclub events increased and the feedback from clubs has been very positive.

MIGHTY ELEVENS AND TEST TEAM

The Mighty Elevens and Test Team series run in conjunction with BMX New Zealand is extremely well organised and highly successful. The event nearly died around five years ago but has since been built up to a fantastic event with great tradition. The Test Team Managers have been working very hard with BMX NZ to standardise the way the event is run in both countries, a MOU (Memorandum Of Understanding) has been drawn up to provide consistency across Australia and New Zealand.

STATE TEAM

The newly introduced financial plan has been a huge success in providing the riders with the assistance needed to attend multiple key events in 2019, the selection criteria is based on performance and has also proven to be positive, BMXNSW will continue to develop both the criteria and the financial plan moving forward, ensuring the focus is placed on the riders

MERIT TEAM

The Board of BMXNSW have introduced a Merit Team, the team consisted of riders who are 9 - 13 years of age and achieved 1st, 2nd and 3rd in the BMXNSW State Series, the State Team Manager and Mentor with assistance from State Team athletes conducted a number of training/coaching days this year, the feedback received was very positive, riders are looking forward to achieving the required outcome and are keen to participant in the coming year

FINANCE

This year marks the completion of a number of finance goals set for BMX NSW which include the following. 1. Implement a funding model for our State Team athletes to support the demands of the National Series and make the team stand-out across all states in Australia. 2. We moved to a single event finance model to improve revenue sharing between host clubs and the state. 3. We continue to make technology and equipment investments with a focus to make life easier for all volunteers. 4. Changed the rider contributions for the Test Team to better reflect to costs incurred by BMX NSW.

BMX in the Northern Territory continues to grow with more events now than ever on the NT race calendar.

The BMXNT Grand Tour is in its second year of running and is proving to be very popular with younger riders who enjoy travelling around the Territory with their families and competing at the different tracks. The series has strengthened the BMXNT community by providing opportunities for riders and their families to engage with other club members and for some of our more experienced volunteers and officials to share their knowledge amongst other clubs upskilling their volunteers and officials, which is a fantastic outcome for the sport.

The Northern Territory Sports Awards were held in April recognising the achievements of athletes, coaches, sporting officials and volunteers. Satellite City BMX Club rider, Caitlin Jong, was awarded NT Junior Sportsperson of the Year which is awarded to a junior athlete who has achieved outstanding results in respect to their performances at an international and/or national level thanks to her performance at the 2018 BMX World Championships where she attained W5 in the 13 girls challenge class.

In June, the Satellite City BMX Club hosted the fourth stage of the BMX Australia National Series. Disappointingly, the event only attracted 171 riders despite the UCI points on offer. A fire threat in the surrounds of the precinct caused some delay to the event but it was otherwise successful with a number of local Members of the Legislative Assembly in attendance.

Highlighting another talented Territory rider, Jingili BMX Club's, Ian Orr, did an awesome job working his way through the motos to take out World 5 in the 14 Boys at the 2019 World Championships in Zolder, Belgium in July.

The BMXNT Titles close out the NT race calendar for the year. This year the BMXNT Titles are hosted by the Jingili BMX Club in what will be their 40th year of racing which is a major milestone for the club. The event currently has some 248 entries registered from all five local clubs and a number of interstate clubs from WA, QLD, VIC, SA and ACT. The pre-event to the BMXNT Titles is the final round of the BMXNT Grand Tour which will also be hosted by Jingili BMX Club and will be sure to get riders ready for the major event.

Looking to the future, BMXNT has actively participated in the AusCycling workshops to ensure that our local clubs interests are protected and that they will continue to have representation at a state level under the proposed AusCycling model. BMXNT has promoted the AusCycling model and participated in the local roadshow to try and ensure clubs are informed of the opportunities that the model will open to the sport.

PARTICIPATION

There are currently 724 memberships held across the five clubs in the Northern Territory. Of which, 201 were female members representing 28% of the membership base. The net change in membership at this point in time is 390 members, with 704 new registrations offset by 305 non renewals which were largely in the Open license category (143 or 47%).

BMXNT kicked off the year by exhibiting at the Defence Community Organisation's Welcome to the Top End Expo for Defence Families at the Darwin Convention Centre providing another fantastic opportunity to interact with defence families and promote participation in the sport. This year the exhibit included a visual display which was a great draw card and conversation starter.

NT clubs also held several Ride in 2 BMX days throughout the year to try and increase the rate of participation in the sport.

COACHING

There are currently 32 valid coaches across the five clubs in the NT with 11 at Jingili, 6 at Satellite City, 6 at Big Rivers, 5 at Red Centre and 4 at Nhulunbuy. The majority of the 32 coaches are club or beginner however, a large number of those are inactive in terms of actually delivering coaching sessions at their respective clubs.

BMXNT engaged Jade McPherson to deliver a number of coaching sessions to NT riders across all five clubs during the year. The clubs have also engaged coaches directly for their members on more than one occasion.

OFFICIATING

There are currently 72 valid Officials across the five club in the NT with 14 at Big Rivers, 22 at Jingili, 13 at Nhulunbuy, 5 at Red Centre and 18 at Satellite City.

State Officiating Director, Karolynn Maurice continues to be proactive in encouraging volunteers to take on the officiating pathway and this effort is evidenced by the increased number of Officials that the NT now has.

Throughout 2019, BMXNT continued to provide financial support to our Officials to attend the National Series events to gain greater exposure and experience.

Highlighting some of the NT's most dedicated Officials. Jingili BMX Club's, Jacqui Dobson, was awarded BMX Australia's 2019 Female Official of the Year.



CLUB DEVELOPMENT

During the year, BMXNT engaged Michael Connelly from CPR Group to undertake a facility network evaluation and committee governance training program at each of five clubs across the Territory. The aim of the project is to prepare a BMX Northern Territory Facility Network Evaluation Plan, to identify and prioritise BMX facility needs across the Northern Territory and to provide evidence-based, strategic guidance to improve the coordinated approach to facility development to cater to all levels of riders in the Northern Territory. In addition, the training and mentoring workshops provided education and tools to support good governance and legislative compliance to our club committees.

Over the past twelve months BMXNT has been proactive in delivering coaching courses as well as officiating courses to the clubs across the Territory to try and encourage more volunteers to become accredited. These courses are provided free of charge as an incentive to volunteers with the support of the Northern Territory Government's peak sporting body grant.

The BMXNT Grand Tour provides an opportunity for BMXNT to work hand in hand with each club to educate and upskill their volunteers and officials through the planning and delivery of their respective round.

The Barkly BMX Club in Tennant Creek completed their track build in September and they are largely on their way to becoming the NT's sixth affiliated club, which will see an additional round on the 2020 BMXNT Grand Tour series.

Looking forward to 2020, the focus will be on increasing grassroots participation and development for the longer term benefit of the sport.

2019 has been a busy and rewarding year for BMX Qld, with the introduction of several new initiatives in the 2019 race season.

BMX Queensland hosted 4 state level events this year, which included our new UCI C1 Queensland International Cup and BMXQ also introduced the new State Development Series to the 2019 program. The Queensland International Cup was successfully held on April 6th at the Brisbane Supercross track at Sleemans Sports Complex in Chandler with over 600 entries and supported by the BMX South Qld Shootout round. This event will be an annual event in conjunction with the Brisbane Cycling Festival.

The new redesigned State Development Series was run over 5 Regional events plus points being awarded for 3 State events being the Qld Country, Qld City and culminating at the Qld State Championships, eight events in total. The Series was well attended and sponsored by BMX Tracks Australia. Qld Clubs ran 46 regional events over 32 available weekends.

2019 BMXQ State Championships was held in Sarina, North Qld and was well attended with 920 entries. The Sarina BMX Club provided BMX Qld with a world class facility and the atmosphere and weather where perfect for a great event. A huge Thank You to all the volunteers, Club members and officials who made this event possible. Also a big thank you to our major sponsors.

The statewide Volunteer Support package conducted throughout Qld in conjunction with CPR is progressing well this year and is providing much needed support for BMXQ, Zones and club committees continuing in the club category and facility audit areas.

BMX Qld volunteers and officials have once again this year provided considerable support to the BMXA National Series and National Championships with most of the head roles at these events being filled by Qld volunteers. BMX Qld is very passionate about looking after their volunteers/ officials and support the officials' pathways.

The One Cycle/ Aus Cycling concepts have taken up a lot of the last few months with workshops and roadshows and clarification of the voting process in Qld with our zones. The Qld vote will be conducted at the Nov 9th BMXQ Mid-Year conference.

We have had a very busy year with the implementation of two new grants, one for Coaching and Officiating and one for High Performance. These grants have allowed us to expand our scope of support and are proving to be beneficial to riders, coaches and volunteers.

Our State Coach, Dino Rokov, attended all national series rounds as part of this funding, providing much needed support to our riders at all levels. This is the first full year of HP team completed, we have made changes to our operations to move the selection of riders from financial to calendar year.

This fits better with the racing calendar for HP riders.

We had an exceptionally good showing at National Championships with 25% of our competitive class entries making Finals.... Including 7 National Champions and a further 8 making Podium.

It has been identified that a more structured mentoring/training program for officials would be beneficial in ensuring all are working at capacity with a solid understanding of the structure and rules. This provides consistency for the clubs and the riders. We have recently commenced a mentoring program for club level, utilising our National Officials. We are looking forward to reporting back next year as to the progress.

Following the surprise resignation of our President and Secretary in March following the State Titles it has been a slow process of rebuilding our State Board. As the then Vice President I stepped up into the position of President and Mrs Deborah Quill took on the role of Secretary whilst maintaining her role as Treasurer. As we were the only two remaining members of the Board, we approached Mr Stephen Van Anholt to fill the role of SOD in the interim giving us a quorum to be able to continue the business of BMX Tasmania. We were then able to advertise for the vacant positions - now filled by Mr Patrick Berry as Vice President and Mr Perry Karras as SOD. These positions were filled following a vote by the three Tasmanian clubs to avoid any conflict of interest by the remaining Board members (as we were few). We still have been unable to fill the vacant Treasurer's position but will continue to advertise and hope that it will be filled in the near future.

In the brief time that the new Board has been in place we have run three very successful rounds of the State Series and will be also running the 2019 State Coaching Clinic at the end of August. I feel the new Board has the necessary skills and experience to take BMX Tasmania into a new and exciting phase.

The Board then appointed Stephen Van Anholt as the State Training portfolio administrator which has enabled us to move forward with some much-needed coaching and officials' courses.

The 2019 State Titles were run on the 9th and 10th of March following the need to change the date due to conflicting with the National Championships. These were very successful with both State and Interstate riders converging on the Launceston BMX Club Track for the event.

Wynyard BMX Park is undergoing a major track rebuild with a new start hill, gate and major alterations to the track. Due to uncooperative weather it has taken a little longer than expected to bring it to race standard but will be completed in time for the last round of the State Series later in the year and I'm sure it will be a fitting conclusion to our huge year of State events.

Southern City BMX Club in Hobart is progressing with their major work as well in preparation for the National Series Round 6 on the 21st September. The track works will see a new start gate, bitumen corners and the installation of lights for night racing.

To compliment the National Series Round Southern City BMX Club are hosting the biggest prize pool event in Tasmanian history with their Clash 4 cash on the 22nd September - with a massive prize pool of \$10,000. This will be the biggest weekend of racing in Tasmania since the National Championships in 2002 and we are all very excited about the event.

Launceston BMX Club are also progressing with investigating funding opportunities to upgrade their track and we wish them the best of luck in their pursuits. Launceston BMX Club holds our highest member numbers in their region for the State and were very successful in hosting a National Series round last year.

As current President I feel the future of BMX Tasmania is looking promising and as our member numbers continue a steady upward trend myself and the BMX Tasmania Board look forward to the challenges to take our sport to the next level.

Increased numbers of riders and officials as well Bacchus Marsh BMX track being built after 9 years of hard work petitioning local government. 2018 State Titles in Warrnambool saw riders from across Australia and overseas enjoy not only the racing across the weekend, but the surrounding attractions along the shipwreck coast. 2019 BMX State Championships are being held in Casey November 22-24 which will include riders from across Australia and overseas, including the Thai National Team.

The Welcome to Victoria event in Shepparton prior to BMXA national championships was a success and gave riders an opportunity to ride the track prior to a great week of racing & also access to the 8m hill that Shepparton Council have added to the venue. We look forward to Shepparton hosting World Cup Round in February 2020.

Following years of Cycling Victoria conducting BMX events as part of their Victorian Schools Cycling Cup, 2019 has seen the inaugural BMX Victorian School Championships conducted across two days in Lilydale and Bendigo. The majority of volunteer roles are already filled prior to each event, which is fantastic and it is part of the qualifying process for our riders towards the end of series awards presentations. We also have the added bonus, with the introduction adding official volunteer roles into the OSM profile for each person at the end of each event. Records will be on hand for officials when it comes time for their re-accreditation.

Volunteer recognition is very important and we continue to award one person each event with a voucher of thanks for assisting throughout the day.

Each volunteer also goes into the draw to win their riders nominations fees paid for the following year. We also like to assist the clubs in recognising their Volunteer of the year by presenting an award and certificate to each clubs "Club Volunteer of the Year" at our end of season awards ceremony. This allows them to be recognised not only by their own clubs, but all other clubs in attendance as well.

EVENTS

With 10 rounds of the State Super Series nearly finished for another year, and planning underway for the next it is looking like being another busy year ahead. We would like to take this chance to thank each Club that hosts a round of the Super Series as we know how much work goes into maintaining the track and surrounds. Also thank you to all our volunteers, riders, parents and guardians it's a big year of racing around the State for everyone. Notes to the Financial Statements

For the Year Ended 30 June 2019

The financial report covers BMX Australia Ltd as an individual entity. BMX Australia Ltd is a not-for-profit Company limited by guarantee, incorporated and domiciled in Australia.

The functional and presentation currency of BMX Australia Ltd is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated.

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

1 Basis of Preparation

In the Directors opinion, the Company is not a reporting entity since there are unlikely to exist users of the financial statements who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. This special purpose financial report has been prepared to meet the reporting requirements of the *Corporations Act 2001*.

The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting Interpretations, and the disclosure requirements of AASB 101 *Presentation of Financial Statements*, AASB 107 *Statement of Cash Flows*, AASB 108 *Accounting Policies, Changes in Accounting Estimates and Errors* and AASB 1054 *Australian Additional Disclosures*.

2 Change in Accounting Policy

Financial Instruments - Adoption of AASB 9

The Company has adopted AASB 9 *Financial Instruments* for the first time in the current year with a date of initial adoption of 1 July 2017.

As part of the adoption of AASB 9, the Company adopted consequential amendments to other accounting standards arising from the issue of AASB 9 as follows:

- AASB 101 *Presentation of Financial Statements* requires the impairment of financial assets to be presented in a separate line item in the statement of surplus or deficit and other comprehensive income. In the comparative year, this information was presented as part of other expenses.
- AASB 7 *Financial Instruments: Disclosures* requires amended disclosures due to changes arising from AASB 9, this disclosures have been provided for the current year.

The key changes to the Company's accounting policy and the impact on these financial statements from applying AASB 9 are described below.

Changes in accounting policies resulting from the adoption of AASB 9 have been applied retrospectively except the Company has not restated any amounts relating to classification and measurement requirements including impairment which have been applied from 1 July 2018.

(a) Revenue and other income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Company and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

All revenue is stated net of the amount of goods and services tax (GST).

Grant revenue

Grant revenue is recognised in the statement of surplus or deficit and other comprehensive income when the Company obtains control of the grant, it is probable that the economic benefits gained from the grant will flow to the entity and the amount of the grant can be measured reliably.

When grant revenue is received whereby the Company incurs an obligation to deliver economic value directly back to the contributor, this is considered a reciprocal transaction and the grant revenue is recognised in the statement of financial position as a liability until the service has been delivered to the contributor, otherwise the grant is recognised as income on receipt.

BMX Australia Ltd receives non-reciprocal contributions of assets from the government and other parties for zero or a nominal value. These assets are recognised at fair value on the date of acquisition in the statement of financial position, with a corresponding amount of income recognised in the statement of surplus or deficit and other comprehensive income.

Interest revenue

Interest is recognised using the effective interest method.

Subscriptions

Revenue from the provision of membership subscriptions is recognised on a straight line basis over the financial year.

Other income

Other income is recognised on an accruals basis when the Company is entitled to it.

(b) Income Tax

The Company is exempt from income tax under Division 50-45 of the *Income Tax Assessment Act 1997*.

(c) Goods and services tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

(c) Goods and services tax (GST) (cont'd)

Receivables and payable are stated inclusive of GST.

Cash flows in the statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

(d) Cash and cash equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

(e) Inventories

Inventories acquired at no cost, or for nominal consideration are valued at the current replacement cost as at the date of acquisition, which is the deemed cost.

(f) Property, plant and equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment.

Plant and equipment

Plant and equipment are measured using the cost model.

Depreciation

Property, plant and equipment, excluding freehold land, is depreciated on a straight-line basis over the assets useful life to the Company, commencing when the asset is ready for use.

The depreciation rates used for each class of depreciable asset are shown below:

Fixed asset class	Depreciation rate
Plant and Equipment	10-33%

At the end of each annual reporting period, the depreciation method, useful life and residual value of each asset is reviewed. Any revisions are accounted for prospectively as a change in estimate.

(g) Financial instruments

For comparative year

Financial instruments are recognised initially using trade date accounting, i.e. on the date that the Company becomes party to the contractual provisions of the instrument.

On initial recognition, all financial instruments are measured at fair value plus transaction costs (except for instruments measured at fair value through profit or loss where transaction costs are expensed as incurred).

Financial Assets

Financial assets are divided into the following categories which are described in detail below:

- loans and receivables;
- held-to-maturity investments.

Financial assets are assigned to the different categories on initial recognition, depending on the characteristics of the instrument and its purpose. A financial instrument's category is relevant to the way it is measured and whether any resulting income and expenses are recognised in profit or loss or in other comprehensive income.

All income and expenses relating to financial assets are recognised in the statement of surplus or deficit and other comprehensive income in the 'finance income' or 'finance costs' line item respectively.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They arise principally through the provision of goods and services to customers but also incorporate other types of contractual monetary assets.

After initial recognition these are measured at amortised cost using the effective interest method, less provision for impairment. Any change in their value is recognised in profit or loss.

The Company's trade and other receivables fall into this category of financial instruments.

In some circumstances, the Company renegotiates repayment terms with customers which may lead to changes in the timing of the payments, the Company does not necessarily consider the balance to be impaired, however assessment is made on a case-by-case basis.

Held-to-maturity investments

Held-to-maturity investments are non-derivative financial assets with fixed or determinable payments and fixed maturity. Investments are classified as held-to-maturity if it is the intention of the Company's management to hold them until maturity.

Held-to-maturity investments are subsequently measured at amortised cost using the effective interest method, with revenue recognised on an effective yield basis. In addition, if there is objective evidence that the investment has been impaired, the financial asset is measured at the present value of estimated cash flows. Any changes to the carrying amount of the investment are recognised in profit or loss.

(g) Financial instruments (cont'd)

Financial liabilities

Financial liabilities are classified as either financial liabilities 'at fair value through profit or loss' or other financial liabilities depending on the purpose for which the liability was acquired.

The Company's financial liabilities include borrowings, trade and other payables (including finance lease liabilities), which are measured at amortised cost using the effective interest rate method.

Impairment of financial assets

At the end of the reporting period the Company assesses whether there is any objective evidence that a financial asset or group of financial assets is impaired.

Financial assets at amortised cost

If there is objective evidence that an impairment loss on financial assets carried at amortised cost has been incurred, the amount of the loss is measured as the difference between the asset's carrying amount and the present value of the estimated future cash flows discounted at the financial assets original effective interest rate.

Impairment on loans and receivables is reduced through the use of allowance accounts, all other impairment losses on financial assets at amortised cost are taken directly to the asset.

Subsequent recoveries of amounts previously written off are credited against other expenses in profit or loss.

For current year

Financial instruments are recognised initially on the date that the Company becomes party to the contractual provisions of the instrument.

On initial recognition, all financial instruments are measured at fair value plus transaction costs (except for instruments measured at fair value through profit or loss where transaction costs are expensed as incurred).

Financial assets

All recognised financial assets are subsequently measured in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

Classification

On initial recognition, the Company classifies its financial assets into the following categories, those measured at:

- amortised cost

Financial assets are not reclassified subsequent to their initial recognition unless the Company changes its business model for managing financial assets.

Amortised cost

Assets measured at amortised cost are financial assets where:

- the business model is to hold assets to collect contractual cash flows; and
- the contractual terms give rise on specified dates to cash flows are solely payments of principal and interest on the principal amount outstanding.

The Company's financial assets measured at amortised cost comprise trade and other receivables and cash and cash equivalents in the statement of financial position.

Subsequent to initial recognition, these assets are carried at amortised cost using the effective interest rate method less provision for impairment.

Interest income, foreign exchange gains or losses and impairment are recognised in profit or loss. Gain or loss on derecognition is recognised in profit or loss.

Impairment of financial assets

Impairment of financial assets is recognised on an expected credit loss (ECL) basis for the following assets:

- financial assets measured at amortised cost

When determining whether the credit risk of a financial assets has increased significant since initial recognition and when estimating ECL, the Company considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information and analysis based on the Company's historical experience and informed credit assessment and including forward looking information.

The Company uses the presumption that an asset which is more than 30 days past due has seen a significant increase in credit risk.

The Company uses the presumption that a financial asset is in default when:

- the other party is unlikely to pay its credit obligations to the Company in full, without recourse to the Company to actions such as realising security (if any is held); or
- the financial assets is more than 90 days past due.

Credit losses are measured as the present value of the difference between the cash flows due to the Company in accordance with the contract and the cash flows expected to be received. This is applied using a probability weighted approach.

Trade receivables

Impairment of trade receivables have been determined using the simplified approach in AASB 9 which uses an estimation of lifetime expected credit losses. The Company has determined the probability of non-payment of the receivable and multiplied this by the amount of the expected loss arising from default.

The amount of the impairment is recorded in a separate allowance account with the loss being recognised in finance expense. Once the receivable is determined to be uncollectable then the gross carrying amount is written off against the associated allowance.

Where the Company renegotiates the terms of trade receivables due from certain customers, the new expected cash flows are discounted at the original effective interest rate and any resulting difference to the carrying value is recognised in profit or loss.

Other financial assets measured at amortised cost

Impairment of other financial assets measured at amortised cost are determined using the expected credit loss model in AASB 9. On initial recognition of the asset, an estimate of the expected credit losses for the next 12 months is recognised. Where the asset has experienced significant increase in credit risk then the lifetime losses are estimated and recognised.

Financial liabilities

The Company measures all financial liabilities initially at fair value less transaction costs, subsequently financial liabilities are measured at amortised cost using the effective interest rate method.

The financial liabilities of the Company comprise trade payables.

(h) Impairment of non-financial assets

At the end of each reporting period the Company determines whether there is an evidence of an impairment indicator for non-financial assets.

Where an indicator exists and regardless for indefinite life intangible assets and intangible assets not yet available for use, the recoverable amount of the asset is estimated.

Where assets do not operate independently of other assets, the recoverable amount of the relevant cash-generating unit (CGU) is estimated.

(h) Impairment of non-financial assets (cont'd)

The recoverable amount of an asset or CGU is the higher of the fair value less costs of disposal and the value in use. Value in use is the present value of the future cash flows expected to be derived from an asset or cash-generating unit.

Where the recoverable amount is less than the carrying amount, an impairment loss is recognised in profit or loss.

Reversal indicators are considered in subsequent periods for all assets which have suffered an impairment loss.

(i) Leases

Lease payments for operating leases, where substantially all of the risks and benefits remain with the lessor, are charged as expenses on a straight-line basis over the life of the lease term.

Lease incentives under operating leases are recognised as a liability and amortised on a straight-line basis over the life of the lease term.

(j) Employee benefits

Provision is made for the Company's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

Employee benefits expected to be settled more than one year after the end of the reporting period have been measured at the present value of the estimated future cash outflows to be made for those benefits. In determining the liability, consideration is given to employee wage increases and the probability that the employee may satisfy vesting requirements. Cashflows are discounted using market yields on high quality corporate bond rates incorporating bonds rated AAA or AA by credit agencies, with terms to maturity that match the expected timing of cashflows. Changes in the measurement of the liability are recognised in profit or loss.
