

LEGACY SANCTION REQUIREMENTS

ROAD AND TRACK - QUEENSLAND

- Category 5 Events must be registered with Cycling Queensland (**AusCycling**) and shall appear on the CQ (**AusCycling**) Calendar of Events.
- Line entries may be accepted.
- A sanction fee or rider Levy may be charged, the fees to be determined by the CQ Board (**AusCycling Management**).
- Appointment of all Commissaires shall be done by the organising club.
- The Chief Commissaire is to be accredited Level 2 (**Regional 2**) or above.
- A maximum prizemoney pool for the event shall be \$1,000.
- A list of all entrants, results and Chief Commissaire's report of the meeting shall be forwarded within seven days by the event Chief Commissaire to CQ (**AusCycling**).

Category 5 events will not be sanctioned against a Category 4 event (now called silver) of the same discipline on the same day

ROAD – NEW SOUTH WALES

- A maximum entry fee is \$30.
- Junior (U15 and U17) riders may ride in open grades in accordance with the rules and restrictions as outlined in the [AusCycling Junior Policy](#).
- Prize money (total cash and/or value in kind) must not exceed \$1,500 in total for the carnival and must be published prior to the start of each event.

- Prize money cannot be allocated to any Junior event (U9 – U17) under any circumstance. Junior riders permitted to race against older riders are eligible to receive the prize money allocated to that particular event.
- Riders competing on a AusCycling 4-week trial membership or other temporary Day Race Membership can only compete in the two lowest grades, must be escorted by an experienced guide for the entire race and are not entitled to claim prize money. In the event of Handicap style events, riders must have a current AusCycling All Disciplines membership.
- All riders participating in a sanctioned race event must sign a waiver prior to starting in the event. Sign-on records must be retained by the host club for the remainder of the current year plus one year in case needed for insurance purposes. All sign-on records must display the following Event risk acknowledgment waiver for riders to read:
 1. *I understand, acknowledge, and accept that cycling is an inherently dangerous sport, which may result in severe injury or death from a collision, fall, mechanical failure, physical exertion, or other incident*
 2. *I voluntarily participate in this event at my own risk.*
 3. *I waive any rights I may otherwise have against AusCycling, the event promoter and their agents and representatives relating to, and agree they are not responsible for, any loss or damage resulting from my participation in the event, including any loss that may arise from death or injury to myself or others, or damage to any property.*
 4. *I agree to follow the directions of any event organiser or official and the AusCycling Technical Regulations and policies.*
 5. *If the participant in this event is under 18 years of age, I warrant that I am a parent or guardian of the participant and agree for myself and the participant that I provide the acknowledgements, agreements and waiver set out above in respect of the participant*

This clause is to be printed at the top of the event sign-on sheets and/or placed on the online registration portal and include signatures acknowledging and/or tick box option so all riders are aware of this point.
